If you know someone who has demonstrated commitment and leadership potential, please email the nominee's name to the election committee (Elections@aaeausa.com) by March 8, 2011 nomination deadline.

Please note that candidates must be a current member to be qualified for nomination. The nominations will be posted publicly and updated regularly on the web site. Any nominee may request that his/her nomination be withdrawn by sending email to the Election Committee by the due date.

Once the nomination process is completed, the Election Committee will prepare the voting ballot. The ballot will be emailed and posted on the web site and able to be downloaded and printed. More instructions about the election process will follow.

The Election Committee strongly encourages the non-registered members to be registered members by the election date in order to be qualified for voting.

Please Note:

- There will be no nomination accepted after nomination deadline date and floor nominations during the meeting will not be accepted also.

- The ballot will be emailed to all on (and posted on the website) where you have to fill out & sign then either fax, mail back or bring to the meeting.
